METER LOCATION REQUIREMENTS

Include Plat of Survey with this application, and mark the following information on the Survey.

The spot where your electrical contractor will be installing the electric meter socket with an "E".

The measurement from the corner of the house to the desired electric meter location.

Any above or below ground obstructions that are between the street and meter location. For these obstructions, circle the appropriate items below and mark them on your Plant of Survey or sketch. Choose your meter location carefully because there is a charge for relocating your meter/service. The electric meter should be located on the exterior wall closest to the facilities from which it will be served to avoid additional installation charges.

Private Underground Facilities

Waterloo Utilities, or a contractor working for the company, will be excavating or boring your property in order to install your electric/water service line. To avoid damage to any private facilities (i.e. underground tanks, lighting, sewer, well, sprinkler, water, etc.) by Waterloo Utilities (and/or contractor), you are responsible for clearly and accurately identifying all private underground facilities with paint and/or stakes. A Waterloo Utilities representative must be informed of all private facilities and proposed construction sites at time of application.

Waterloo Utilities (and/or contractor) will not be held responsible for any damage whatsoever to any private underground facility as a result of a lack of identification. The cost of any repairs to damaged private underground facilities and any additional expenses due to known or unknown private facilities will be your responsibility. If you need assistance in locating your private underground facilities, contact a locating contractor in the yellow pages under Utilities-Underground, Cable, Pipe & Wire Locating Service. Please do not call Diggers Hotline, as they are unable to locate privately-owned facilities. Sewer and water laterals located between property line and meter are considered private facilities and must be marked.

Customer acknowledges that Waterloo Utilities facilities will be attached to the Customers building and that the attachment of Waterloo Utilities facilities may affect certain Customer warranty rights. Customer agrees to indemnify, defend and hold Waterloo Utilities its directors, officers, employees and agents harmless from all judgements and claims, including attorney fees, relating in any way to Customers loss of warranty rights as a result of any action taken on the part of Waterloo Utilities to install facilities and equipment.
